- All competitors should report to secretaries' tent on arrival, and should bring with them, their horse passport of competing horse plus their start fee (£15.00/ entry) #
- All competitors must provide their own number bibs. Numbers for insertion will be provided on the day.

- Official stewards will carry out hat & body protector checks, at warm up for each phase, **Any rider found to wearing non safety compliant head gear or body protector will waive their right to compete.**

- Dogs, if permitted at the venue, must be kept on short leads.
- REMEMBER, horses and ponies are unpredictable animals and every care must be taken to be responsible at all equestrian events.
